- 3. All the II semester students must register **ONE** Skill Enhancement Course under Edx Platform Online course either in Group I or Group II equivalent to the Skill Enhancement subject chosen by him/her.
- 4. Hence, all the II semester students must undergo **Two** Skill Enhancement Courses and at least ONE edX Online course equivalent to the Skill Enhancement Course he has chosen.
- 5. It is resolved that the edX course carries the same number of Credits i.e., 2 (two) Credits as carried by the Skill Enhancement Course. Hence there is no disturbance in the total number of Credits in the overall Programme. Thus who got online certificate (edX) are exempted for writing University exam of that students.
- 6. This resolution comes into force with immediate effect in the academic year 2023-24 for the II semester students.
- 7. The edX course is to be adopted and implemented in hybrid mode, by exposing the students to online content available on edX platform under the supervision of the concerned MENTOR and also explicating the content in the classroom. Hence, the edX course has both online and offline content delivery in the classroom.
- 8. The timelines for the said edX Course are to be followed scrupulously and must coincide with the University End-Semester Examinations.
