### ACTION TAKEN REPORT FOR THE YEAR 2019-20

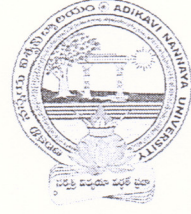
- Finalization and approval of feedback on curriculum from students and teachers for the academic year 2018-19.
